Reimbursement for In-Office, Endoscopic Carpal Tunnel Release (IOECTR) Surgery JAN 2022

GOAL:

Obtain reimbursement for Office-Based Surgical Suite (OBSS) ovehead for hand-and-wrist procedures that have zero Site of Service Differential (SOSD)

Help surgeons negotiate a Carve-Out for fair OBSS overhead reimbursement.

Strategy: Educate/Advocate to Providers, Associations and insurance companies

Work with professional Associations: AAOS and ASSHW to help all surgeons interested in Office-Based Surgical Suite(OBSS), WALANT (Wide Awake Local Anesthesia with No Tourniquet), and IOECTR

Insurance Companies

Fair OBSS overhead reimbursement from insurance carriers

Office-based overhead reimbursement needs to be negoiated up-front as a "Carve-Out."

Increase the expertise of surgeons in contracting for facility fees reimbursement.

Three ECTR OBS Reimbursement Options:

- 1) Claim Deniend (wrong Place of Service)
- 2) Professional Fees Only (no office practice expenses)
- 3) A SOSD negotiated for direct and indirect OBSS overhead.

Overhead Fee is included in Office NON-FAC PE (Practice Expense) RVUs
